


HOLD HARMLESS AND RELEASE AGREEMENT

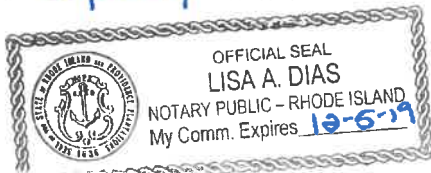
