HOMESTEAD EXEMPTION APPLICATION R.I.G.L. 44-3-34

CHAPTER 34, SECTION 45 OF CITY OF CENTRAL FALLS ORDINANCES

The Homestead Exemption provides tax relief to each person who is a domiciled resident of the City on or before December 31 of each year and which property is the principal residence (owner-occupied) of said person. The exemption is applied to RESIDENTIAL property with a total of five (5) residential units and may include up to one (1) commercial or professional unit as part of the total of five (5) assessed units.

QUALIFICATIONS FOR THE HOMESTEAD EXEMPTION REQUIRE:

- 1) A valid copy of the applicant's Driver's License OR State Issued Personal Identification Card with the appropriate address.
- 2) A valid copy of the applicant's Vehicle Registration with the appropriate address.
 - a. <u>If the applicant does not own a vehicle</u>, the attached NON-OWNERSHIP of MOTOR VEHICLE AFFIDAVIT MUST BE COMPLETED along with a copy of their Federal or State Income Tax Return.
- 3) A current (as of 12/31) Voter Registration Card, Bank Statement or Utility Bill mailed to the appropriate address.
